#### Job Description - CAFTA

Reporting to the Executive Director, the Trade Policy Officer will play an operational support role in backing the mandate of the organization.

The Trade Policy Officer will undertake the following;

- Assist in the monitoring of trade policy developments and related legislative matters
- Conduct broad research including on trade statistics, for preparation of trade policy materials (presentations, briefings, monthly newsletter, appearances before parliamentary committees etc.)
- Assist in the management of the CAFTA office and provide support for operations as needed in accordance with core competencies of the job
- Coordinate lobby meetings, communications and outreach

**R**eporting to the Director of Government and International Relations the Trade Policy Officer will support CCA's domestic and international trade policy development and analysis

- Monitor international trade notifications and preparation of CCA response when required
- Maintain and monitor relevant trade data
- Develop and maintain country profiles
- Develop and disseminate trade policy materials (presentations, briefings, communications etc.)
- Foreign Trade Committee support in partnership with the Director
- Assist with events and lobby days as part of the CCA Government Relations Team
